Your member section shall be represented in the General Assembly by "from one to five delegates" depending on the number of registered architects it represents, as follows:

- from 25 to 100 Architects : 1 Delegate
- from 101 to 300 Architects : 2 Delegates
- from 301 to 500 Architects : 3 Delegates
- from 501 to 1000 Architects : 4 Delegates
- More than 1000 Architects : 5 Delegates

Only official delegates shall have the right to vote at a General Assembly.
